

**Minutes of the Parish Council Meeting**

**Held on Thursday, 24 November 2011**

**at 7.30 pm in the Village Hall, Barmby Moor**

**Present:** Councillors Spencer, Woods, Shepherd and Van Dam. Julia Gregory (Pocklington Post).  
The Chairman confirmed the meeting was quorate.

**Matters Arising:**

**Upgrading street lights** – clerk to email all councillors to view the new LED lights at Meltonby, then discuss at the next meeting.

**Website** – Raymond Rowe (webmaster) would like more information on the website. Photographs of the village; events i.e. Village Hall, Church, School etc.

**Emergency Plan** – 500 letters to be delivered to each house in the parish, via each Councillor and the clerk.

**Street nameplates** – Cllr Shepherd confirmed the delivery date is Wednesday, 30 November.

**Grass cutting and wildlife area on Beckside** – Cllr Spencer has had a meeting with Denise Lee & Kate Fretwell who are going to attend an ER training session.

**West End bungalows, pedestrian access** – chase ERYC for an answer.

**Litter Bin A1079 bus stop** – email confirming litter bin will be installed within 2 weeks.

**Parking on Village Green outside Ash Tree Cottage** – double parking has stopped. Cllr Spencer contacted ERNLLCA for a legal letter to send to offending residents in other parts of the village. Problem places West View, Holborn View and the Vicarage entrance.

**Business sign at The Laurels** – has been removed.

**Verge wastage outside the Village Hall** – needs rebuilding, contact Highways.

**Bollards on Village Green** – red bands to be removed by Cllr Spencer.

**Streetscene Services** – repairs reported to Highways, including cycle path signs on A1079.

**Queens Diamond Jubilee** – consider beacons, seat, plaque or mugs at the next meeting.

**Cycle Rack** – no answer as officer on leave until 5 December.

**Tomlinson, Tall Timbers extension to first floor – (C)** extension should be built in keeping and sympathetically with the surrounding buildings.

**Tree Works** – The Briars – remove dead parts of dying tree.
